News From University Human Resources

OSU Benefits anticipates mailing open enrollment materials on or around October 9, 2025, and changes to your enrollment can be made between October 13 and November 7. Changes made during this time will become effective January 1, 2026. There will not be any vendor changes; health and prescription drug insurance remain with BlueCross BlueShield of Oklahoma; vision with Vision Service Plan (VSP); and dental with Delta Dental of Oklahoma.
