# Membership

From hereon, Association is used when referring to the Emeriti Association. Membership in the OSU Emeriti Association is open to all retired employees of OSU, spouses of current or deceased Emeriti members, retired federal personnel associated with OSU, the Board of Regents, and retirees from other academic institutions within the Oklahoma A&M System. As contained in the Constitution of the Association, other retirees with a significant relationship to Oklahoma State University may become members upon approval of the Emeriti Council. Other retirees should present their interest to the President of the Emeriti Council. A membership application is on the Emeriti website.

Current Association members are encouraged to recruit new members. The monthly dinner meetings are a good way to introduce and inform prospective members. Guests who are prospective members receive a one-time complimentary meal.

#### **Emeriti Council**

Management of the Association is vested with the Emeriti Council. A Council member, referred to as a Councilor, serves a three-year term and is limited to two consecutive terms. Current Councilors are shown below. Past president serves as parliamentarian.



#### **General Information**

An overview is provided on some Association policies, committees, and interest groups. For additional information on policies, please contact a member of the Council. Participation by the membership in Association activities is encouraged. #### Constitution and Bylaws

The Emeriti Association Constitution and Bylaws are on the Emeriti website. The Association Policies and Procedures and history are also on the website. Every odd year or as needed, the Constitution, Bylaws, and Policies and Procedures are reviewed and if necessary amended.

#### **Dues**

Annual Membership dues are \$25.00 per person or \$35.00 per couple and are due on January 1. Annual dues not received by March 1 may cause the member's name to be excluded from the updated directory.

Life Membership dues are \$200.00 per person or \$250.00 per couple. Life membership is a one-time payment at the time selected.

Checks for annual dues and life membership are payable to the OSU Emeriti Association and should be mailed to the Emeriti Association mailing address shown on page 2.

## **Emeriti Council Business Meetings**

The Emeriti Council holds its monthly business meetings on the last Monday of the month except for December when held on the second Monday. Due to the Memorial Day holiday, the Council will meet on Monday, May 21, 2018. The Emeriti Council does not hold a business meeting in June and July. The business meeting location is the Emeriti Suite, Room 101 of the ConocoPhillips OSU Alumni Center.

#### **Facilities Requests**

The Emeriti Association facilities are located in the ConocoPhillips OSU Alumni Center. Requests by non-member groups to use the Emeriti Association facilities shall be brought to the Emeriti Council for referral to the Alumni Association for consideration.

#### **Investment Club**

The Investment Club is an Association interest group for Association members who enjoy learning about stock market investing in a friendly, supportive environment. This group elects its own officers and is governed by a Partnership Agreement and set of bylaws. Participation requires a modest financial commitment. Each member is a partner and has a share in the Investment Club's stock portfolio. Visitors are welcome at Club meetings. Those interested in joining are required to attend three Club meetings before applying to become a partner.

## Making the Most of Retirement

The Association co-sponsors with the Stillwater Public Library the Making the Most of Retirement monthly presentations. Making the Most of Retirement is an Association interest group and includes the Armchair Travel series along with other topics of special interest to retirees, and overviews of local programs and agencies. The presentations are by guest speakers and take place at the Stillwater Public Library. The Association members receive monthly emails on the title of the presentation and date and time scheduled.

# Membership in Emeriti Association

Membership in the OSU Emeriti Association is open to all retired employees of OSU, spouses of current or deceased Emeriti members, members of the Board of Regents, retirees from other academic institutions within the Oklahoma A&M System, and retired federal personnel associated with OSU. Other retirees with a significant relationship to OSU may become members upon approval of the Emeriti Council.

Association members who know of eligible recent retirees and other prospective members are encouraged to refer the names to the Emeriti Council. Literature on the Association and an application will be sent to the prospective member.

#### **Membership Meetings**

No fewer than eight meetings of the Association are scheduled each year. These are typically dinner meetings held on the first Monday of each month. Meetings are not held in January and the summer months. An announcement on the meal and program is emailed (some mailed by request) to members. To ensure adequate food and seating, reservations are required by the date noted in the announcement.

#### **Meet and Greet Reception**

The Meet and Greet reception precedes the monthly dinner meetings and allows additional time for informal interaction among the dinner attendees. The reception is held in the Emeriti Suite, Room 101 of the ConocoPhillips OSU Alumni Center. Light snacks and both nonalcoholic beverages and wine are offered. A small contribution is accepted to cover the expenditures for the reception.

#### Members Age 90 and Older

Members age 90 or older receive a complimentary meal at the monthly dinner meetings. Please contact the chair of the Membership Committee when reaching this age.

#### **News and Periodic Information**

A calendar, updates, and other information typically are distributed at each monthly dinner meeting. Newsletters are mailed twice a year to Association members. The Emeriti website provides information on upcoming events, as well as previous updates and newsletters.

Officers and Committee Chairs Job Descriptions

Each officer and committee chair shall update his/her job description yearly by the September meeting. The President shall provide a job description to each new officer and committee chair. Copies are made available for the nominating committee to use in contacting candidates. Committee chairs prepare an end-of-year report.

**Programs Committee** 

The Programs Committee identifies and schedules speakers for the monthly dinner meetings. Suggestions are welcome on topics and speakers, which are referred to the Programs Committee chair shown on page 6.

Scholarship Program

The Association has a scholarship endowment fund with the OSU Foundation. From it, an annual scholarship is awarded to a student at Oklahoma State University. Donations are welcome. There is the potential for a larger award or two annual scholarships as the endowment fund grows. A donation is an admirable way to honor and memorialize relatives and friends. Donations are payable to the OSU Foundation and include on the check memo line or in a letter "Oklahoma State University Emeriti Association Scholarship Fund."

**Technology Interest Group** 

The Technology Group is an interest group for Association members who would like to learn more about the use of computers and cell phones. Basic and more complex technological information is studied on such topics as Window basics, computer maintenance and security tips, smart cell phone use, and new technology among a host of other topics. Helpful explanatory handouts are provided and available on the Emeriti website.

#### **Volunteers**

Requests for Emeriti members to serve as volunteers at campus or other events should be referred to the chair of the Ambassadors/Alumni Relations Committee.

Volunteer opportunities exist for Association members. Two are assisting the Alumni Association on football game days and distributing programs at the University commencement exercises. Other volunteer opportunities periodically occur. Interest in participating as a volunteer should be referred to the chair of Ambassadors/Alumni Relations Committee shown on page 6.

#### Website

The Association maintains a website for the membership. Information on the website includes monthly updates, past newsletters, minutes of the Emeriti Council, Emeriti scholarship program for OSU students, and Association membership application among other items. # **Retiree Benefits Information**

The Emeriti Association continues to be proactive in following and suggesting OSU programs and services beneficial to retirees. Various ones currently available are described below. Some OSU departments or programs listed herein may have different rules for Emeriti Association members who are OSU retirees than those who are not.

Information regarding benefits is subject to change during the year. Please contact the appropriate department for more information and updates.

# **Apple Computer Discounts**

Academic discounts on Apple Computers are available at the Student Union Bookstore. A valid OSU ID must be shown at the time of purchase. Call the Bookstore at 405-744-4357 for details.

## **Auditing Courses**

OSU retirees who retired under the OTRS Rule of 80 or Rule of 90 and anyone age 65 or older may audit OSU courses. Laboratory and studio art courses and private music lessons are not open for audit. The instructor's permission is required. A *Request to Audit a Course* form is available online at registrar.okstate.edu. Call the Office of Registrar at 405-744-6876 for details.

# **Campus Parking Permits**

OSU retirees who have 20 years of consecutive service and 20 consecutive years of obtaining an OSU parking permit are entitled to receive a retiree parking permit at no cost. A retiree with less than 20 years of consecutive service is eligible to purchase a staff parking permit at the current price. Parking permits must be picked up in person from OSU Parking and Transit Services located in the Multimodal Transportation Terminal. A parking permit is valid only for the personal use of the retiree to whom issued. Call 405-744-6525 for more information.

#### **Edmon Low Library**

Retired faculty and staff may check out books and other permissible materials and access software. An OSU ID or Emeriti membership card is required. Emeriti members may access digital library services through the internet at library.okstate.edu. Call the librarian at 405-744-9780 for additional information or help.

#### **Email**

OSU retirees may retain their OSU email addresses. For questions regarding an O-Key account, contact the IT Help Desk at 405 744-4357.

#### Lake Carl Blackwell (LCB)

There is no charge for day visitation to OSU Emeriti members. A "day use" pass is required and obtained by showing one's Emeriti membership card at the LCB Headquarters (next to the store) or the Fee Collection Booth (when open) at the entrance. Vehicles not displaying a permit are subject to ticketing by OSU Police Department.

#### **OSU Athletic Events**

OSU retirees may purchase season tickets to athletic events at a reduced price. When purchasing

in person at the Athletic Ticket Office, a retiree must present one's OSU ID card. If ordering by mail, a photocopy of one's OSU ID card must be included. Call the Athletic Ticket Office at 405 744-5745 for ordering information and other details.

#### **OSU ID Cards**

OSU ID cards will remain valid in retirement. Lost cards must be reported immediately to prevent unauthorized use. There is a \$20 replacement fee. The ID Services office is located in 421 Classroom Building. Check it.okstate.edu or call 405 744-8434 for questions and additional information.

# **OSU Michael and Anne Greenwood School of Music**

Tickets for music events are available at the current student rate to members of the Association and other senior citizens. Check the website music.okstate.edu or call 405-744-8997 for a list of upcoming musical events and purchasing tickets.

**OSU Department of Theatre** 

Senior citizens age 65 or older are eligible to purchase tickets at a reduced rate. Attendees with disabilities may request seating in a designated row. Check the website theatre.okstate.edu or call 405-744-6094 for upcoming theatre events and purchasing tickets

# **OSU Student Government Association Events**

Most events sponsored by the OSU Student Government Association are free to OSU retirees with a valid OSU ID. This includes the OSU Speakers Board events. Admission restrictions and fee requirement likely will be listed in the advertisement for the event.

Parking in Student Union (SU) Garage

OSU Emeriti Association members are given a 50% discount on hourly parking in the SU garage. There is a minimum charge of one hour. A current Emeriti membership card must be shown to the parking attendant to receive the discount.

### Seretean Wellness Center and Colvin Center

OSU retirees are given an automatic free membership to the Department of Wellness and only need to show one's OSU ID to be admitted. Other retired employees may purchase membership on a semester or annual basis at the community membership rates. Check the website wellness.okstate.edu or call 405 744-5510 for additional information.

**Transit System** 

Passengers reaching age 59 may ride the local OSU buses one way for thirty-five cents. The BOB transit service is available to the public at the same rate as for current faculty and staff. The one-way fare is \$13.00. Reservations are required for riding BOB. Check the website parking.okstate.edu or call 405 744-7100 for routes, making reservations or additional information on the local buses and BOB.

# Anne Matoy, 2017 Association President

The year 2017 provided numerous opportunities for the Emeriti Association to meet its organizational purpose "to enhance and encourage the educational, professional, and social interactions among retirees at Oklahoma State University and to interact with other individuals and groups in ways that enhance the education and welfare of retired persons."

Accomplishments were not possible without the dedication and commitment of many individuals including the Emeriti Council officers and members, committee chairs, and Council appointees to University and faculty committees. Many on committees have continued to serve through multiple years.

The Emeriti Association financial condition continues to be solid. As of December 31, 2017, there were expendable assets of \$35,750. Our endowed scholarship fund with the OSU Foundation enabled us to award our second scholarship. This year the award went to Devin Peck, a sophomore from Shawnee, majoring in Chemistry.

We received a large monetary gift from Kathryn McCollom in honor of Kenneth McCollom, who was one of our Emeriti Association founders. A study group has been appointed to consider how best to use the donation. We were fortunate to receive several other monetary gifts at the end of the year. Additional contributions are always welcome, and are tax deductible.

Membership decreased slightly, and at the year-end was at 541 members. After eighteen months of not receiving new retiree information due to a major changeover in the University computer system, we were finally able to secure new retiree information on a regular basis. We urge you to invite prospective members and let both recent and not so recent retirees know of our fun, fellowship, and continuing opportunities for service to the University and the community. Unfortunately, we lost 28 members as is reflected in our Memoriam listing.

The Emeriti Association close relationship with the University keeps us up to date on happenings and changes that can affect retirees. We are fortunate to have Emeriti Association representatives on University and faculty committees.

We greatly appreciate the support from the Office of Provost. The Provost graciously covers many of our expenses and administrative support by Misty Burk who is primarily an OLLI assistant. Misty is invaluable to our communications efforts with Emeriti members through the newsletters, monthly updates, and handling the monthly dinner reservations among other duties.

The Alumni Center provides valuable support by providing space for an office and the Emeriti Council Suite. We are pleased that the Emeriti Ambassadors are able to assist the Alumni Center during football season with greeting visitors. At the close of the year, we began

discussions on best utilization of resources to meet both Alumni Center and Emeriti Association needs, and plan on an update to our current agreement in the next year.

The Ambassadors also assist at both spring and fall commencement exercises. With multiple sessions, plenty of volunteers are needed to pass out commencement programs and direct attendees. Commencement is always a wonderful celebration for students and their families. Being able to share in student success is a great experience.

The Emeriti interest groups Technology, Making the Most of Retirement, Armchair Travel Series, and Investment Club continue to provide fun and fellowship as well as new avenues for continual learning. Whether it being an update on all things digital, armchair cruising from Cape Town to Singapore, learning about new volunteer opportunities and services available in Stillwater, or investment know how, there is always something new to learn and do through Emeriti Association programs.

Emeriti Association members enjoyed two trips during the year. Pioneer Woman fans were enthralled with a trip in April to Pawhuska to eat and shop at the Pioneer Woman Mercantile, and later tour the Cathedral of the Osage, a 1910 French Gothic-styled church known for its stained glass windows. On a side tour to view the grasslands, a buffalo greeted our travelers. The December trip to Branson featured four shows and a light display with time for shopping.

The monthly dinner meetings provided programs that were both entertaining and informative. The Meet and Greet time before the dinners allowed yet another way to make new friends and renew acquaintances. While attendance varied, we averaged 85 attendees at the nine regular dinner meetings. Food and gratuity costs nearly matched the ticket price, with the Emeriti Association covering additional charges for setup, AV, etc.

It has been my pleasure to serve as President during both 2016 and 2017. The Emeriti Association has an excellent team in place for 2018. I know you will continue to volunteer and support its many endeavors.
